MV MALITA OFF-SERVICE

Gozo Channel would like to inform its esteemed clientele that the MV Malita shall be off-service at the dry dock from **Wednesday 6th February till Tuesday, 12th February 2019**.

To compensate for the decrease in vehicle capacity, as from Wednesday 6th February 2019 the morning trips, **between Monday to Friday** from Mgarr and Cirkewwa will be operated as follows:

Other trips will be performed according to the published schedule and a shuttle service will also be provided if demand so necessitates. **The company will also ensure that the MV Ta' Pinu is operated with both hoistable decks down so that it can cater for the heavy traffic as and when necessary.**
